License Activation Policy for Zelenka Reporting Solution


License activation procedure:

There are 2 methods for Zelenka's license activation.

Common steps for both methods:

1) The Zelenka Reporting Solution is available for free download on the following link:

https://www.zelenkareports.in/downloads




2) Click on the Zelenka Reporting Tool 2_1_0_0, it will prompt for the path where you want to save the file. Click on the save & download the folder.

- **3)** Download the **Installation Guide** from the same link.
- **4)** Follow the procedure shown in the "Installation Guide" document for the software installation.
- **5)** User can start using the software once it is installed.
- 6) We recommend that before activating the license, user can decide the configuration strategy, finalize the report structure, finalize the tags, types of reports to be used, their design etc. using configurator. The screen path for the configurator is shown below:



Method 1 (Recommended):

- i) Using viewer, generate the reports for auditory report generation.
- ii) Once the audit is done, install software at the end user's system.
- iii) To activate the license, the end user should provide the product key & product code generated in the "Report Module Setup" to the application vendor. See below:




- iv) They will provide the license activation key which the end user has to insert in the "Activation Key" section of the "Report Module Setup".
- v) Thus, Zelenka's product get licensed.
- vi) We recommend activating your final license in End User's Environment.

Method 2:


- i) By default, "DEMO APPLICATION" water mark is printed on all generated reports in unlicensed version of Zelenka.
- ii) If user don't want "DEMO APPLICATION" to be printed on the reports for the audit purpose, then use the temporary license feature.

iii) Temporary License

a) Temporary licence can be created by click on "Create Temporary License" as shown below:




- b) This license is valid for 5 days.
- c) If due to some unavoidable reasons you couldn't complete your testing & auditing work in 5 days, license can be extended for 2 days more by using "Extend License" feature as shown here:



- d) The temporary license can't be extended further. System Integrator should plan to conduct FAT during this period by considering the final report structure, types of reports & their design, no. of tags etc.
- e) System Integrator can do the report generation for the audit purpose.
- f) Once the audit is cleared, install the software at end user site & ask for the permanent license.

iv) Permanent License

g) The end user must provide the product key & product code to the application vendor to get the permanent activation license key. See below:



h) The end user can put the permanent activation license key in the "Report Module Setup" to activate the final license.

Note:

Why is Method 2 not recommended?

- 1) The user should note that license depends on the following factors:
- No. of tags used in report.
- Auto scheduler module
- Backup Truncate Restore module.
- No. of Installations

Variation or mismatch in any of the above parameters at FAT (done by System Integrator) & SAT (done by end user) may result in change in product key.

- 2) Changes in the design or structure of the report after installation may result in change in product key.
- 3) Environmental change may result to change in product key.

That's why we recommend Method 1 i.e., Client Site (end user site) license activation.
